1. The Artiste(s) are responsible for their own Income Tax and National Insurance Contributions.
2. The Booker and Artiste(s) will arrange any re-bookings directly.
3. Invoiced payments will be made to Artistes within 7 days of receipt of invoice.
4. Cancellation by Booker. A full fee will be payable where less than 14 days' notice of the performance date is given. Deposits are non-refundable but can be applied to an agreed change of date.
5. Cancellation/Non-Appearance by Artiste(s): except in the event of certified illness or accident or circumstances beyond the control of the Artiste that could prohibit the performance of the Artiste, the Artiste(s) will be liable for any losses and/or additional expenses actually incurred by the Book up to the amount of the contract fee. If, however the Artiste or Agency can replace themselves with a like act for the same fee, then there is no liability.
6. Provided the Booker pays the Artiste(s) his full contractual salary, he may without giving any reason prohibit The whole or any part of the Artiste(s) performance or exclude the Artiste(s) from any or all performances. The Artiste is not obliged to take directions in relation to performance from the Booker. The Artiste is only obliged to perform his act as known.
7. The Artiste is not obliged under this contract to take part in any photographic, sound, tape or video recordings. Permission should be sought from the Artiste as a courtesy.

8.The Booker shall provide reasonable dressing rooms and adequate sound equipment and shall provide up to three soft drinks during the event for the performer.

9 Times are part of this contract and it may not always be possible to perform later than contracted as other engagement may not allow to adjust times on the night.
